The years ahead are full of hope and promise for Walden. We understand the difference that one person, and one organization, can make in the life of a child or youth. The people in these pages are a testament to that.



We provided **429** families a total of **13,834** hours of coaching and birth family visitation.

Our foster care program served a total of **294** children. Of these children, **58** required specialized care and support due to disabilities or healthcare needs. Less than **1%** of Walden's children experience more than one placement compared to California's state average of **36%**\*.

## **FOSTER CARE**

Kids who come into foster care have often experienced prolonged stress and trauma. Quality foster care programs like ours help kids heal. Walden's foster care program ensures that children and youth of all ages – especially kids who need specialized care – have the opportunity to grow up knowing the stability, love and sense of community that family life provides.

## Foster Parent Spotlight:

## Blanca and Raul

"We've been foster parents through Walden for over 10 years, and we even adopted our daughter through Walden several years ago. During this time we've been fortunate enough to have many children in our care. These kids need us, and we need them too. We are so happy in their company. We play together, have fun together, and keep each other busy. We get attached to these children, but we are so happy when they are reunified with their parents. And their parents are so appreciative of what we've done. We keep in touch, and they'll send pictures and messages."



### Social Worker Spotlight: Marla

#### Foster Care Social Worker

"The children we serve are often victims of neglect, abuse and abandonment. When they reach us, our ultimate goal is to help them recover from the stress and trauma that that brings. I've witnessed firsthand the difference that the Walden foster care program offers these children – security, happiness and a specialized program tailored to their individual needs. They deserve only the best, and that is what we give them."



In 2016, **80** children found their forever home and family thanks to Walden.

## **ADOPTION**

Walden was licensed as a full-service adoption agency in 2008. While the circumstances of each adoption are unique, the process typically takes 6 to 18 months during which time a Walden social worker works closely with the prospective adoptive family on a thorough match process. Each family goes through training to ensure they can offer a healthy, happy home to children that are often recovering from childhood trauma.





### Adoptive Parent Spotlight: Oraisa and Shindana

Oraisa and Shindana were certified for foster care and adoption with Walden in 2011. Since then, they have cared for a total of 16 children, many of whom were eventually placed with relatives or reunified with their parents. They met their daughter in June 2015, and this past January, it became permanent when her adoption was finalized. "Ineana 'came home' in 2015. It hasn't always been easy, but we are so happy. We're a family now."

## Social Worker Spotlight:



Adoptions Social Worker

"Being an Adoptions Social Worker with Walden Family Services is an honor and a joy. I take great pride in helping families through the process of adoption and helping children get settled and comfortable in their forever home. The journey of adoption is not an easy one for our families, but the love and commitment they have for their children supersedes all barriers. I've had the honor of witnessing several adoptions finalizations in court, and I can tell you, nothing touches your heart more than being a part of this major life event."

## PREVENTION

Walden operates several prevention programs including:

### • NURTURING PARENTING

Nurturing Parenting is a 16-week program that offers young parents an opportunity to develop critical skills needed to nurture their children, build self-awareness and self-esteem, and communication skills. It also offers them a comfortable place to build meaningful relationships with peers also experiencing the same challenges.

### · CAL-LEARN

Cal-Learn helps teen parents break the cycle of foster care by providing them with support to graduate high school, become responsible parents and ultimately move toward self-sufficiency.

### **EXTENDED CARE/AFTERCARE**

As foster youth transition from a structured foster care system to living as an independent adult, many realize they need help to succeed. Extended care provides one-on-one coaching on education, employment, health and safety, and establishing lifelong relationships.

In 2016, your donations helped **502** young people get the support they desperately need through our prevention

programs.

The high-school graduation rate of youth in the Walden Cal-Learn program is **88%** compared to **30%** statewide\*.

## Nurturing Parenting Youth Spotlight:

Ray

"One of the things that has resonated with me from the program is taking care of myself. You can only offer your children as much as you are. If I am only operating at 60%, that means my daughter is only getting 60%. I want to give her 100%. She deserves me at my very best."

"One of the facilitators really stressed reading with your child. The very next day I read my daughter a book, and she started mimicking the sounds I was making. I was in awe! I couldn't believe it. I couldn't wait to come back and tell the facilitator what had happened."

Ray completed the curriculum last year and is currently in the process of becoming a peer parent volunteer for the program. Next up for him is going to college. "Before taking these classes, I never even dreamed of going to college. People from my city don't do that. I've learned so much about success, motivation and making progress towards goals."

## Social Worker Spotlight:

"Nothing is more rewarding than seeing these youth that face so many obstacles dedicate themselves to our rigorous parenting program to better their lives and the lives of their children. So many of the teens and young adults in our program don't have the family support one needs to raise a child. Our program teaches them vital skills and offers them a safe place to meet peers facing the same challenges as them."






WALDEN FAMILY SERVICES | 2016 Impact Report

In 2016, **236** youth transformed their lives by participating in our THP+FC program.

**58%** of Walden THP+FC youth held employment, compared to **48%** of youth in statewide THP programs\*. The remaining **42%** of Walden THP+FC youth attended school or gained workplace skills.

## TRANSITIONAL HOUSING PLUS FOSTER CARE (THP+FC)

Most young people still have their parents to turn to for help even after they turn 18. But 65% of foster youth in California leave foster care at 18 with no place to call home. This incredibly innovative housing and foster care program provides youth with the essentials needed to begin taking care of oneself on their own. Youth in our transitional housing plus foster care program learn how to live on their own in the community, build relationships with mentors and earn a college degree or learn a vocation.

## THP+FC Youth Spotlight:

#### Dian

Diana was placed in foster care when she was 14-years old. When she was 18, she entered Walden's THP+FC program and has since gone on to earn a full-time job at a beauty store while she studies to become a make-up artist, her true passion. Of her time with Walden she says, "Thank you for turning a horrible experience when I was young into a positive one now. I wouldn't be the success I am becoming today if it weren't for Walden and this program."

## Social Worker Spotlight: *Cheryl*

THP+FC Social Worker

"The sense of accomplishment a Walden youth feels when they graduate from our THP+FC program is unmatched. You can see the utter pride and happiness on their faces, which makes doing my job all the more rewarding. So many of these youth have no one rooting for them besides Walden. We support them. We embolden them. We help instill a sense of confidence that they can face the world and chase their dreams."
